d) Application Number 144233. Land at Brigg Road, Caistor (Mr Stevens). - Ref: 1039

Application for approval of reserved matters to erect 48no bungalows considering appearance, landscaping layout and scale – following outline planning permission 136604 granted 22 January 2019.

Caistor Town Council objected to the original planning application (131181) in June 2016 and again in respect of the re-submission (136604) in September 2017. Nothing has

changed and the council believe the points raised in the objections are still relevant today.

The council are particularly concerned regarding highway safety given the position of the highway

access/egress, which is approached from the west, the site is on a bend and in

summer is shaded by tree growth. Another major concern is waste water, sewage disposal and surface water; placing 'conditions'; on the decision does not mean they will be complied with.

Caistor Town Council are of the opinion that Waterhills is not suitable for a housing development of any size.
